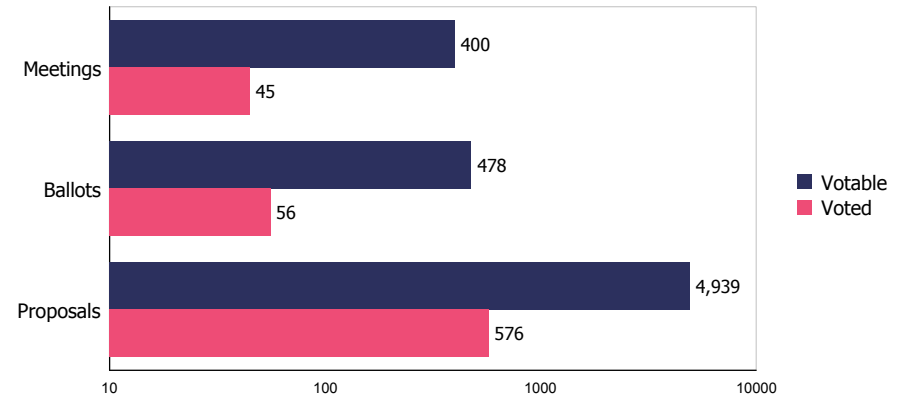

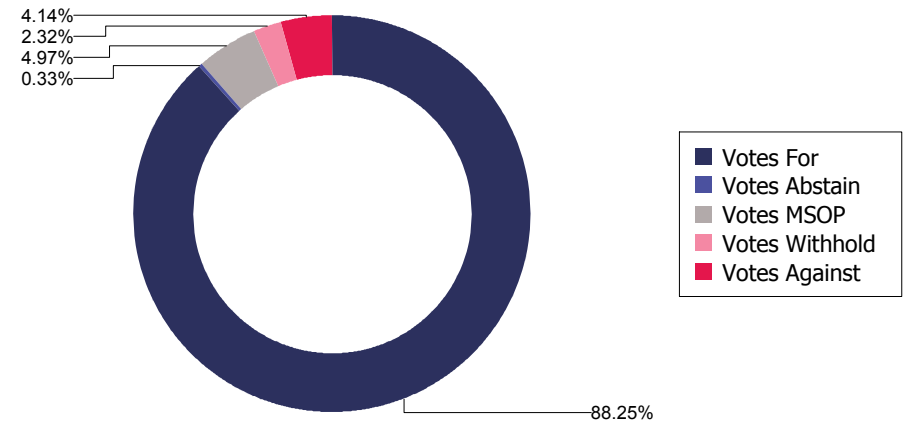

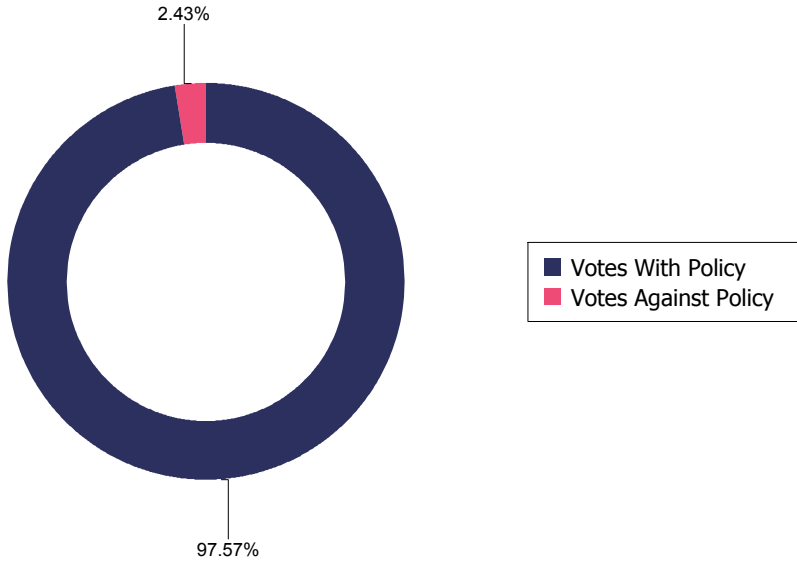

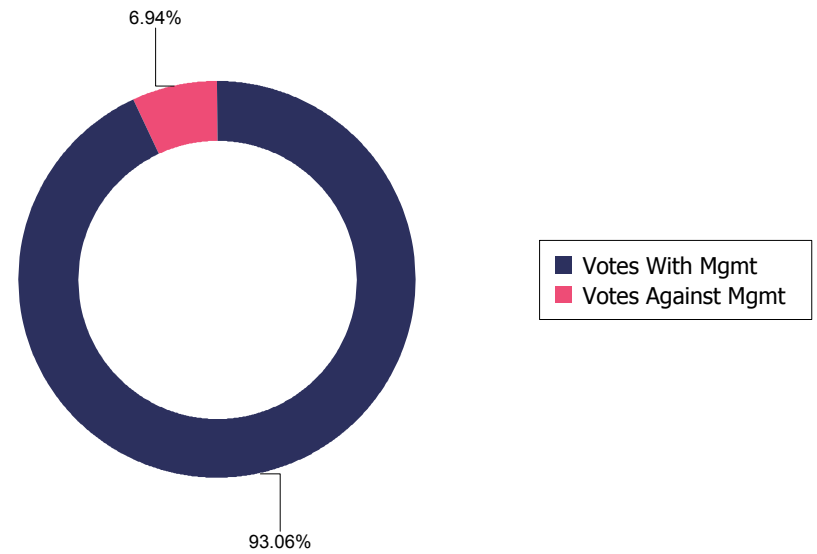

Vote Alignment with Policy



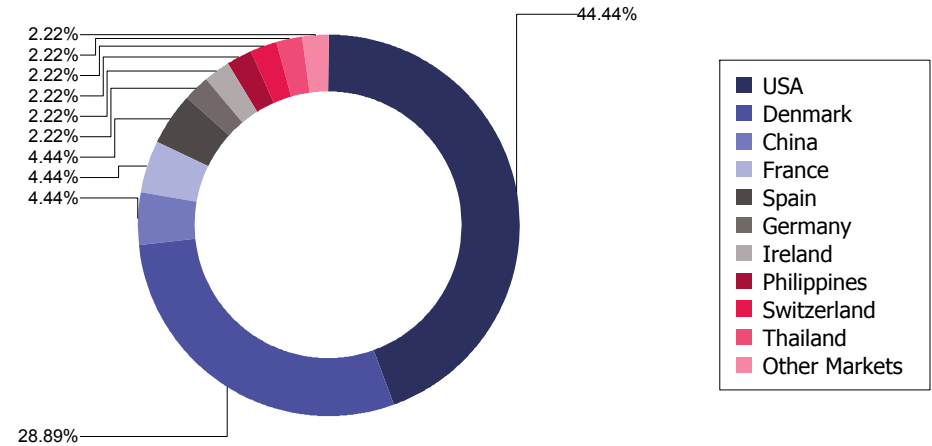

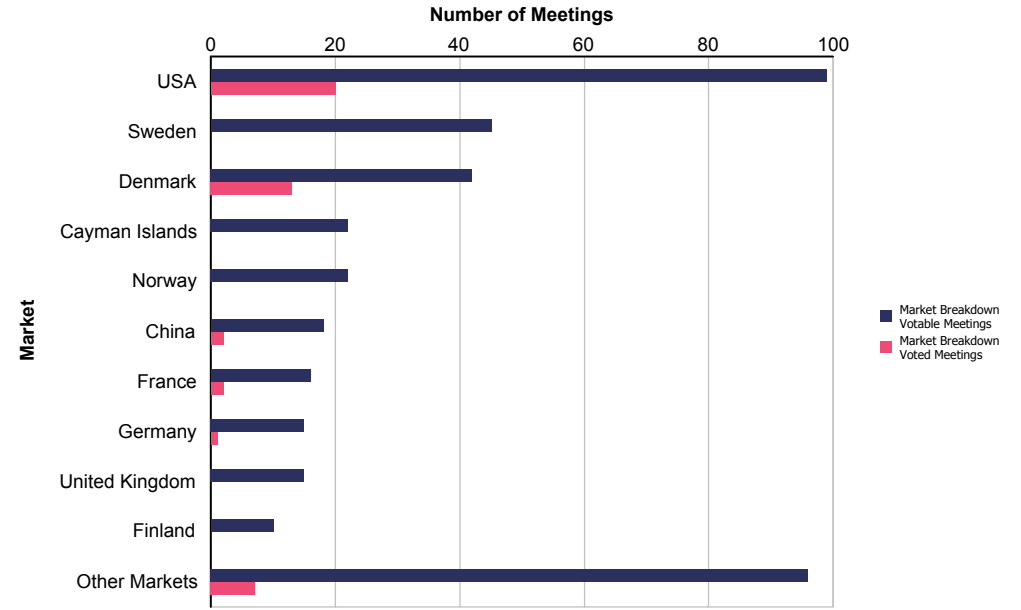
